

PayPoint Park Christmas Savings First Order Reward Terms and Conditions

These Terms and Conditions ("**Terms**") govern this promotion offered by Park Retail Limited © 2024 Park Retail Ltd to individuals who place an Order and make an initial payment of £25 or more in the PayPoint Park Christmas Savings Scheme ("**Promotion**") from 1 February 2024 and 31 March 2024 ("**Promotion Period**").

Please read the following Terms carefully and keep a copy for your information.

1. Eligibility

1.1 In order to be an eligible participant for the Promotion, you must be over 18 years of age and must not be employed by any member of the PayPoint group of companies.

2. Promotion

Individuals who meet the eligibility criteria and complete the 2-stage Participation requirements in clause 3 shall be entitled to receive a credit to the value of £10 in their Park Christmas Savings Account ("**Promotion Payment**"), subject to these Terms.

3. Participation

To participate in the Promotion you must complete the following 2 stages:

- 3.1 Stage One- Place an order in the 2024 Park Christmas Savings Scheme.
 - By 31 March 2024 you must:
 - (a) visit a participating PayPoint location and scan the Park QR code which shall be displayed at the point of sale.
 - (b) Place an order in the 2024 Park Christmas Savings Scheme ("**Scheme**") by completing the digital ordering process (which is accessed via the QR code) and selecting the gift cards or vouchers to add to your order and submitting your "**Order**" (being the order for the value of gift cards or vouchers you wish to save for and receive under the Scheme). The Order must be for no less than £25.00 in total.
- 3.2 Stage Two- Complete all Order payments in the 2024 Park Christmas Savings Scheme.
 By no later than 23.59 on 31 October 2024, you must have paid for your Order in full, and your payments must be no less than £25.00.

4. Promotion Payment

- 4.1 You shall receive your Promotion Payment in your Scheme account at the end of your savings cycle being no earlier than 1 September 2024 and no later than 30 November 2024.
- 4.2 For the avoidance of doubt, any £10 credit showing on your Scheme account shall not be made available until and unless all participation requirements have been met.
- 4.3 Use of the Promotion Payment
 All Orders shall be completed by applying your Scheme payments first, and then by applying any credits
 on your account, including the Promotion Payment. If, at the end of the savings period for the Scheme,
 there is a credit on your account including all or part of the Promotion Payment, the credit amount shall

be carried forward and applied against any order that you submit for 2025 Park Christmas Savings Scheme ("2025 Scheme"). If you do not submit an order for the 2025 Scheme, then the credit amount shall be lost and you shall not receive this as part of any rebate or refund.

5. Other Important Terms:

- 5.1 Any participants whose Orders that have been cancelled for any reason whatsoever shall not be entitled to receive the Promotion Payment.
- 5.2 Promoter reserves the right to verify the eligibility of all claims and may, in its sole discretion, refuse to pay the Promotion Payment (or, if a Promotion Payment has been made, remove such Promotion Payment) if the customer fails to satisfy any eligibility or participation requirements set out in these Terms or the Scheme terms (including any identification requirements) or where we suspect that a false or fraudulent submission is being made or misleading information has been given.
- 5.3 Promoter does not accept any liability for lost or delayed payments, howsoever caused.
- 5.4 Responsibility is not accepted for any submitted claims that are deficient, lost, damaged or delayed as a result of any computer hardware, network or software failure of any kind. Promoter reserves the right to reject any claim in its sole discretion.
- 5.5 The decision of Promoter is final in all respects and no dispute or correspondence will be entered into.
- 5.6 Promoter reserves the right to substitute the Promotion Payment for an item of equal or greater value.
- 5.7 This offer is not transferable to any other individual or participant and cannot be exchanged for cash.
- 5.8 The Promotion may be used in conjunction with the 'Refer a Friend' scheme but may not be used in conjunction with any other offer, bonus or commission scheme.
- 5.9 To the extent that you have supplied personal data in relation to this promotion, such personal data shall be used exclusively for the administration of activities in relation to this promotion only. For the avoidance of doubt, this will not change or amend any standing personal information you may have provided in relation to the Scheme or any other products or services provided by the Promoter, or the use of such information in relation to such products or services. - 5.11 If for any reason any aspect of this promotion is not capable of running as planned, the Promoter may (in its sole discretion) cancel, terminate, modify or suspend the Promotion, or invalidate any affected entries (this includes, without limitation, by reason of infection by computer virus, network failure, bugs, tampering, unauthorised intervention, fraud, technical failures or any cause beyond the control of Promoter which corrupts or affects the administration, security, fairness, integrity or proper conduct of this promotion). For the avoidance of doubt, any termination of this Promotion shall not invalidate any Promotion Payment due to any participant who has met the participation requirements prior to the date of termination of the Promotion.
- 5.12 You agree to be bound by these Terms and conditions and confirm that all information provided is accurate, up-to-date and complete to the best of your knowledge and ability.
- 5.13 Promoter reserves the right to withdraw or amend the promotion and/or these Terms at any time, details of which will be shared on here.
